




2.1 REPORTING PATH FOR STUDENTS

2.2 REPORTING PATH FOR TEACHERS



2.3 REPORTING PATH FOR ADMINISTRATIVE STAFF



3. CONTACT CATEGORIES

- A **face mask** is mandatory in the HfM buildings.
- If you do not wear a mask you **risk increases**!
- The duration time is based on **continuous contact** without interruption.



4. CORONA-WARN-APP Download at <u>App-Store / Google-Play-Store</u>

The Corona-Warn-App does not provide information to which contact category a person belongs. It sends you information ("lower risk") or a warning, if you have been close to a Corona-infected person for a longer duration of time ("higher risk").

The application of the Corona-Warn-App is **voluntary** and serves your personal security.
